
Currently in the market clients can choose either a level income or an increasing income:

• The increasing income starts relatively lower, so you may have to make a sudden adjustment immediately after retiring, although it increases yearly to keep up with inflation.

The Assupol *Rewirement* feature allows you to combine the benefits of the fixed and increasing income options – this allows you to start off with a higher, level income, which will start to increase after a few years to better keep up with inflation.
