#### **DETAILS OF HEARING AND REPRESENTATION**

- 1. This is an award which follows the failure by the Employer to honour the Settlement Agreement reached by the parties on the 17<sup>th</sup> of April 2019.
- 2. The arbitration was held on 17 April 2019 at the Employer's premises in Pietermaritzburg, KZN.
- 3. Both parties were represented as stated above.
- 4. The hearing was held under the auspices of the Public Service Co-ordinating Bargaining Council ("the Council") in terms of section 24 (4) 24 (5) of the Labour Relations Act, No 66 of 1995 as amended ("the Act").
- The dispute is about failure by the Employer to implement an Occupational Specific Dispensation
   Collective Agreement, Resolution 1 of 2007 (the Resolution).
- The Employer signed an agreement that it would implement the Resolution by no later than 31
   May 2019, which it became apparent that it failed to do so, hence this award.
- 7. After being apprised of the said failure by the Employer, I asked the Employees to provide me with the details of the amounts that are due to the Employees.
- 8. I received the information above on 10 October 2019 and it includes: Salary scales on which the Employees are being paid and the Salary scales on which they would have been paid had the Resolution been correctly interpreted and implemented; Service records of both Employees dating back to August 2007 (Persal printouts); Calculations of how much is owed to each Employee and the Settlement agreement.
- 9. I received no communication from the Employer in this regard.

### **ISSUE TO BE DECIDED**

- 10. I am required to determine whether the Employer has failed to interpret and apply Resolution 1 of 2007 when it failed to translate the two Employees in accordance with clause 14.1.33 of the Resolution with effect from 01 July 2009.
- 11. The Employees wants to be translated in terms of the Resolution.
- 12. The Employees are employed in the capacities reflected below:-
  - 12.1 R Stuart Control GISc Technician
  - 12.2 C Samuel Chief GISc Professional

# **BACKGROUND TO THE ISSUE**

- 13. Both parties signed a settlement agreement on 17 April 2019.
- 14. The settlement agreement was supposed to be implemented by no later than 31 May 2019.
- 15. The Employer failed to implement the settlement agreement.
- 16. The Employees therefore referred the matter to the Council for the enforcement of the Settlement Agreement.
- 17. This award is therefore issued for the aforementioned purposes.
- 18. In light of the aforesaid, no evidence was therefore led on this matter and the determination is based on the signed Settlement Agreement.
- 19. The Union submitted the table below as calculations and the totals owed to the Employees:-

20. The Union further submitted that the two Employees' basic salaries should from be as follows: -

20.1 R Stuart: R 902 389.88

20.2 CB Samuel: R 932 791.91

21. The union mentioned as part of the back-pay from 01 August 2009 to September 2019, the Employees are owed the amounts below -:

21.1 R Stuart: R 270 716.96

21.2 C Samuel: R 279 796.95

22. The union submitted that the salaries stipulated above should be applicable going forward, as the back-pay is not included in the amounts indicated above with effect from October 2019.

#### **ANALYSIS OF EVIDENCE AND ARGUMENTS**

- 23. Clause 4.13 of the Resolution states that these dispensation will be implemented over the next three years commencing with effect from 01 July 2007. The priorities for implementation for new occupations will be determined by agreement within the sectoral bargaining council.
  - 4.1.4 The revised salary structure per occupation shall be implemented as follows:-
- 4.1.4.3.3 Engineers, architects, environmentalists and other identified professionals, jointly agreed to in the relevant sector with effect from 01 July 2009.
- 24. It is common cause that the Employer has failed to implement the Resolution on this matter, hence it entered into a Settlement Agreement with the intention to do so.
- 25. The union submitted that this dispute is based on clause 4.1.4.3.3 above.
- 26. Based on the documentation and the accompanying calculations submitted by the PSA on behalf of the two Employees, the Employees are owed from 01 July 2009 to 30 September 2019 as follows:-

26.1 R Stuart: R 270 716.96

26.2 C Samuel: R 279 796.95

27. The Employer has failed to correctly interpret and apply the Resolution when it failed to respond to the Employee's grievance within 30 days.

28. Given the fact that the Employer has on 17 April 2019 signed a settlement agreement, acknowledging and agreeing that it needed to interpret and apply the resolution correctly, such interpretation and implementation has been clarified by the union to mean the submissions stated above.

29. The Employer has further failed to submit any differing version from that submitted on behalf of the two Employees.

30. In the consequences, I have only the version from the union and I have no reasons not to accept it.

#### **AWARD**

31. The Employer has failed to correctly interpret and apply the Resolution when it failed to translate the two applicant Employees accordingly.

32. The Employer is ordered to translate the two Employees correctly and place them on the notches below:

32.1 30.1 R Stuart: R 902 389.88

32.2 CB Samuel: R 932 791.91

33. The Employer is further ordered to pay the Employees back-pay from 1 July 2009 to September 2019, and the amounts are as follows:

33.1 31.1 R Stuart: R 270 716.96

33.2 C Samuel: R 279 796.95

34. Furthermore, the Employer is ordered to implement the aforementioned by no later than 31 October 2019.




