Issue in dispute.

Whether the appl cants should be retrospectively upgraded from first level notch of salary le /el seven to 6th level notch on the same salary level as provided by PAM.

The parties agrie to resolve the dispute on the following terms and conditions:

This agreement is made in terms of PAM documents and Collective Agreement 2 of 2 08.

The respondent vill recognise the previous experience of the applicants and adjust their salaries retrospectively.

The salary adjust nent for Khensani Chistopher Nkosi, persal number 13331434, will be adjusted by Enhlazeni TVET College from 3 March 2014 to 31 March 2015. It will further be adjusted by the Department of Higher Education and Training from 01 April 2015 until the date of adjustment. The adjustment will be done not later than 30 March 2020.

The salary adjust nent for Gift Sibongile Nkosi, persal number 147 30065, will be adjusted by Department of Higher Education and Training from 01 June 2015.

With regard to recognition of previous experience, (22 years for Khensani Chrisopher Nkos and 18 years for Gift Sibongile Nkosi), both the Enhlazeni TVET College and the Department of Higher Education and Training will be lie ble. Calculations as to the total amounts due and payable will be done by the persal system.

Parties agreed that the adjustments that goes with recognition of previous work experience will be done by the respondent not later than 30 Mach 2020.

This agreement is in full and final settlement of the dispute referred to the ELRC.
