Settlement Agreement

1. The Applicant lodged an unfair labour practice dispute with the GPSSBC in which he is seeking to be paid an acting allowance for 6 months. (1 October 2020 to 31 March 2021)
2. The parties wish to settle this dispute and herewith record the terms of the settlement, as follows:
 - 2.1. Whereas the matter was scheduled for conciliation hearing on 6 July 2021 before Mr S. Skweyiya a full time Resident Panellist.
 - 2.2. The Respondent party agrees to pay the Applicant a 6 months outstanding acting allowance in the amount of **R62 860.86 (Sixty Two Thousand Eight Hundred and Sixty Rands and Eighty Six Cents)**. This amount in paragraph 2.2 is subject to less SARS tax deductions.

3. This agreement is a full and final settlement of this dispute.




