PSCB494-15/16: THE SETTLEMENT AGREEMENT

#### Whereas:

- The parties in the Council passed Resolution 7 of 2015, Framework Agreement for the establishment of GEHS.
- The employer was supposed to implement the housing allowance agreed upon, i.e. R1200 with effect from 01 July 2015 and did not do so;

### And Noting

- That Organised Labour had declared a dispute at the PSCBC about the interpretation and/or application of a collective agreement.
- That the parties held a pre-arbitration meeting on 18 and 22 January 2016;

The parties agree to resolve the dispute as follows;

1. That the employer has issued an implementation circular on 10 December

2015.

- 2. The employer agreed to make a presentation to the PSCBC as agreed during the pre-arbitration meeting held on 18 January 2016, which presentation was made on 21 January 2016, to discuss the circular issued on 10 December 2015.
- 3. That the implementation workshops be held with departments and provinces from 18 January 2016 (currently being rolled out), the purpose of which is to familiarise staff with the process of homeowners' allowance. Parties further agree to conduct joint implementation workshops under the auspices of the Council.
- Payments in accordance with clauses 4.5.1 and 4.5.2 in terms of Resolution 7 of 2015 shall commence from 15 February 2016 for employees who submit enrolment forms.
- 5. Parties to this agreement herewith consent to this settlement agreement being made an arbitration award in terms of section 142A of the Labour Relations Act of 1995, as amended.
