#### THE APPOINTMENT OF A PANEL OF CONCILIATORS AND ARBITRATORS

#### 1. PURPOSE

This agreement gives effect to clause 15.9 (c) of the Constitution of Council on the appointment of a Panel of Conciliators and Arbitrators for the period 2009/2010.

#### 2. NOTING

- 2.1. The Labour Relations Act (Act 66 of 1995, as amended) section127 (2) provides specific requirements on appointment of a Panel of Conciliators and Arbitrators
- 2.2. The Constitution of the GPSSBC in clause 15.9 (c) requires Council to Appoint a Panel of Conciliators and Arbitrators to perform dispute resolution functions
- 2.3. Clause 8 of the dispute Resolution Procedure of Council provides the procedure and applicable requirements for the appointment of a Panel of Conciliators and Arbitrators.

#### 3. SCOPE

- 3.1 This agreement binds
  - 3.1.1 the Employer;
  - 3.1.2 the employees of the employer who are members of trade union parties to this agreement;
  - 3.1.3 the employees of the employer who are not members of trade union parties to this agreement, but who fall within the registered scope of the Council.

# 4. PARTIES TO COUNCIL THEREFORE RESOLVE THAT

- 4.1. Persons as per annexure A of this agreement are herewith appointed as Conciliators and Arbitrators to perform the dispute resolution functions of Council.
- 4.2. The appointment of such Panellist is subject to the panellist;
  - 4.2.1. signing the Service Level Agreement (Contract of engagement) with Council;
  - 4.2.2. agreeing to be bound by the fee policy for panellist; and
  - 4.2.3. agreeing to be bound by the Code of Conduct and Disciplinary procedure for Panellist.
- 4.3. This agreement will lapse as per the provisions of the Constitution i.e. the next AGM of Council

#### 5. DISPUTE RESOLUTION

Should there be a dispute about the interpretation or application of this agreement any party may refer the matter to the Council for resolution in terms of the dispute resolution procedure of the Council.
