

MEDIA RELEASE: Steinhoff International Holdings class action: PSA joins litigation group

The Public Servants Association (PSA) is set to encourage the Government Employees Pension Fund (GEPF) and the Public Investment Corporation (PIC) to join a class action against Steinhoff International Holding to recoup money lost owing to 'accounting irregularities' that lost shareholders billions in 2017.

The PSA met with representatives of the International Litigation Group (ILG) on 30 October 2018 to discuss actions that could produce faster solutions for shareholders given the multi-jurisdictional approach. The litigation involves law firms from South Africa, the Netherlands and Germany.

"It was important for the PSA to attend the ILG meeting to understand all scenarios that may unfold during this process and to take an informed decision regarding the recovery of losses suffered by especially members of the GEPF. The PSA is satisfied with the actions put in place by parties in pursuit of justice and to hold all involved accountable," said PSA General Manager, Ivan Fredericks.
