Feedback: CIPC Bargaining Forum Meeting - 30 July 2025

Members are aware that negotiations are underway at the CIPC after labour tabled their demands for cost-of-living adjustments and conditions of service. The employer had committed during the meeting on 25 July 2025 to obtain a refreshed mandate after labour rejected the initial offer for 3%. Parties met on 30 July 2025, and the employer presented its final offer as follows:

The employer could not accede to all other demands, *i.e.*, provision of cellphones to all employees, additional leave encashment, and consideration of experience instead of academic qualifications when making appointments. However, the employer is willing to consider the bursary for employees' dependents and the matter will be discussed further in subsequent meetings.

YOUR MANDATE IS REQUIRED!

The PSA members must provide a mandate to **ACCEPT or REJECT** the offer as a package. If accepted, the agreement will be binding in its entirety. If rejected, all elements will be declined.
